

Great Barrier Reef Marine Park Authority, Dallhold Case (Additions) Archive

This collection represents additional and substantial material to the Dallhold controversy in Queensland during the late 1980s, which became a court case between October 1990 and August 1992. It builds on the Dallhold material represented in the Riethmuller Collection (located at Archives 400L-401M).
